Penelitian ini bertujuan untuk menganalisis Rasio keuangan Terhadap Kinerja keuangan Perusahaan Pertambangan yang Terdaftar di Bursa Efek Indonesia. Metode analisis data yang di gunakan yaitu analisis regresi data panel dan uji asumsi klasik dengan bantuan software Eviews. Metode pengambilan sampel yang digunakan dalam penelitian yaitu metode purposive sampling. Sampel berjumlah 34 Perusahaan Pertambangan yang Terdaftar di Bursa Efek Indonesia periode 2017 sampai 2023. Hasil penelitian Secara parsial likuiditas berpengaruh positif dan signifikan terhadap kinerja keuangan pada Perusahaan Pertambangan di Bursa Efek Indonesia, Leverage berpengaruh negatif dan signifikan terhadap kinerja keuangan pada Perusahaan Pertambangan di Bursa Efek Indonesia. Rasio aktifitas berpengaruh positif dan signifikan terhadap kinerja keuangan pada Perusahaan Pertambangan di Bursa Efek Indonesia. Secara simultan likuiditas, leverage dan rasio aktifitas berpengaruh positif dan signifikan terhadap kinerja keuangan pada Perusahaan Pertambangan di Bursa Efek Indonesia.

ABSTRACT

Title : Financial Ratio Analysis Of Financial Performance Of Registered Mining Companies On The Indonesian Stock Exchange

This research aims to analyze the financial ratios of the financial performance of mining companies listed on the Indonesian Stock Exchange. The data analysis method used is panel data regression analysis and classical assumption testing with the help of Eviews software. The sampling method used in the research is the purposive sampling method. The sample consists of 34 Mining Companies Listed on the Indonesia Stock Exchange for the period 2017 to 2023. Research results: Partially, liquidity has a positive and significant effect on the financial performance of Mining Companies on the Indonesia Stock Exchange, Leverage has a negative and significant effect on the financial performance of Mining Companies on the Stock Exchange Indonesia. The activity ratio has a positive and significant effect on the financial performance of Mining Companies on the Indonesia Stock Exchange. Simultaneously, liquidity, leverage and activity ratios have a positive and significant effect on the financial performance of Mining Companies on the Indonesia Stock Exchange.
